



## Updated ATSI Result Letter 2023-10-06

Ganado Unified School District:

Federal School Improvement has completed the 2023 accountability cycle. You should have received a prior version of this email with an attached letter. However, the Federal Achievement Threshold was incorrectly reported in that letter. The Federal Achievement Threshold set in 2022 is a Subgroup Achievement Score (SAS) of 21.99. Any individual school SAS values reported are still accurate.

Populations identified for Additional Targeted Support and Improvement (ATSI) have a one-time opportunity to exit in one year.
