- B. Information and report on SY'2023-2024 A-F Letter Grade for Ganado Unified School District. Marcarlo Roanhorse motions to hear the report on the SY'2023-2024 A-F Letter Grade, second by Wallace James, Jr. Leandra Thomas, Superintendent reported that A-F accountability system which reports on how the letter grades are formulated and the components that go into it. She stated that the documents included are comparisons with surrounding schools which includes the high school, middle school and intermediate schools. Dr. Thomas mentioned that the Primary School is not counted in the state testing so they are not included. The second grade going into the third grade so they contribute to the Intermediate school letter grade. Intermediate School has a letter grade of a B; Middle School has a letter grade of a B; High School has a letter grade of a D. The overall district letter grade is a C. The went over the models of how the letter grades are formulated. She stated that they continue to struggle with teachers no fully on board. Principals and Instructional Services Director provided information on all factors involved in the formulation of the letter grade as well as working toward a goal to maintain or improve the letter grade.
