- 1. Add the following in **bold** to Page 4, Section 5., Summary of Work:
 - 5.3.1 A sample wage determination is provided for reference for Apache County. Wages shall be confirmed with the Office of Navajo Labor Relations (ONLR), as indicated in the corresponding PDF file, "ONLR25-0712B Ganado USD Building Demolition". **Contractors shall use the current wage determination herein and understand that coordination and confirmation will be required by the ONLR upon contract award.**
- 2. Add the following to Page 4, Section 5., Summary of Work:
 - 5.5. Questions and answers provided via "Vendor Discussions" in the Bonfire portal are included as a separate PDF file with seven (7) pages.



5.6 Drawings of the existing buildings are being provided and show all the information we have regarding the existing construction. The drawings are not "As-Built" unless identified as such. We have no knowledge of any changes to what is shown in the drawings. The files are provided in a separate zipped folder named, "Existing Drawings."

- 3. Remove and replace the following in **bold** on Page 16, Uniform Terms and Conditions, Contract Administration and Operation:
 - 2.11 Offshore Performance of Work Prohibited. Any services that are described in the specifications or scope of work that directly serve the District and involve access to secure or sensitive data or personal **Sunnyside Ganado** Unified data shall be performed within the defined territories of the United States. Unless specifically stated otherwise in the specifications, this paragraph does not apply to indirect or 'overhead' services, redundant back-up services or services that are incidental to the performance of the contract. This provision applies to work performed by subcontractors at all tiers.
- 4. Remove and replace the following in **bold** to Page 32, Uniform Instructions to Offerors, Bid Preparation:

- 3.2 Forms: No Facsimile or Electronically Submitted Bid. A bid shall be submitted either on the forms provided in this Solicitation or their substantial equivalent. Any substitute document for the forms provided in this Solicitation will be legible and contain the same information requested on the form. A facsimile or **electronically submitted** Bid **submitted through email** shall be rejected.
- 5. Revise *Attachment 3, Bid Cost Form* to separate the work into Phases: 1) Abatement and 2) Demolition. Bidder understands that the project may be phased based on funding. Remove and replace the *Attachment 3, Cost Form* with the revision included herein in PDF and Excel format.
